As as per the programme regulations, this is the last chance for 2021 admission candidates (2 year MCA) and in the case of 3 year MCA this is the last chance for 2019 admission candidates for First Semester Examinations, .

As the registration in ABC portal is mandatory utmost care should be taken to enter the ABC ID of every candidate in the application for registering the examination

Mode of payment of fee will be SBI e-pay for regular (2024 admission) candidates and SBI Collect for supplementary /Improvement candidates.

The printouts of online applications of regular (2024 admission) candidates shall be retained in the College itself. The printouts of online applications and challan receipts of supplementary/improvement candidates have to be submitted in the University before the last date prescribed.

The Principal shall submit the following documents to the University on or before **21.11.2024, 5 p. m.**

1. The Printout generated after submitting student's data online .
2. Photocopy of the Qualifying Certificate verified and attested by the Principals of Colleges/ Course Directors concerned, as per the Clause 4.2 of UGC Notification October 2018 Regarding Refund of Fees and Non-Retention of Original Certificates. (Attestation by the Principal/Course Director concerned will only be accepted).
3. Equivalency certificate from Kannur University in case of candidates who passed qualifying examination through Distance Education from universities outside Kerala and those who obtained degrees with different nomenclature, (Recognition Certificate is sufficient if the eligibility is any UG degree), as per the instructions contained in the admission prospectus
4. Duly filled Matriculation/Recognition Application attested by the Principal.(only for Students who Passed

their qualifying examination from other Universities).

The Principal/ Assistant Director shall log in and download the detailed statement of fees remitted by the regular candidates and forward an attested copy of the same, along with the affidavits submitted by the candidates receiving grant directly to their bank account, who have not remitted the examination fee during registration.

The eligible **regular** candidates who receive the grant directly to their bank account shall **either remit the examination fee online during registration without opting fee concession or remit the amount to the University as and when it is received from the Government Department concerned.** These candidates shall **submit the affidavit in annexure I, if the examination fee is not remitted during registration.**

The candidates who receive the grant through the institution's bank account shall opt for fee concession during registration. The Head of the Institution shall credit the examination fees of these candidates to the Kannur University Fund and inform details of such remittance to the Examination Branch without delay. If any candidate receiving grant through the institution's bank account has remitted the examination fee during registration, the principal of the College shall reimburse the amount to the candidate.

Penalty will be levied for delayed submission/incorrect submission/ non-submission of data/Applications, as per the university rules. The deadline for submitting applications and data as per the above schedule will not be extended.

Candidates with shortage of attendance will not be issued hall tickets unless the Principal/ Assistant Director recommends and states that the shortage is within the condonable limit and the application for condonation have been forwarded to the Registrar.
